## **Project for the Innocent**



Loyola Law School's Project for the Innocent (LPI) is dedicated to the exoneration of the wrongfully convicted. Loyola Law School students are the heart and soul of the clinic, which is yearlong. If, after a thorough investigation of a case, a true claim of innocence is provable, clinic students will help draft a habeas petition so that the case can be litigated in court.

In August 2015, Paula joined Loyola Law School as the Executive Director of the Alarcón Advocacy Center and Legal Director of its Project for the Innocent. Prior to joining Loyola full-time, Professor Mitchell taught Habeas Corpus and Prisoner Civil Rights Litigation as an adjunct professor.

Paula is Vice Chair of the State Bar of California, Committee on Appellate Courts and holds seats on several boards, including the California Appellate Project, the Women Lawyers of Los Angeles Foundation Board, and the board of Death Penalty Focus.
