"Why a Laser?" explains how lasers work, and what's so great about them that makes them leave lightbulbs in the dark. It also includes an interactive demo/game to show how a laser can read. This talk serves as a prequel that en-hances understanding of the talk "Lasers I Have Loved: Tales from the thrilling life of a laser physicist."

This talk is designed to explain physics in a way that is understandable to any adult, regardless of science or math background (or lack thereof). While aimed at adults, it is also suitable for exceptionally inquisitive teens.

He has a long career researching laser and electro-optical physics in the Los Angeles area, and has been Adjunct Professor of Physics at Moorpark College and California Lutheran University. He is also known for his passionate poetry recitations, portraying Edgar Allan Poe, as well as his comical poetry recitations, parody songs, and stories. Dr. Bobbs is a resident of Redondo Beach.

s my term as President of Omnilore Learning-In-Retirement Inc. draws to a close, this will be my last column. I am deeply honored to have served as the first president of Omnilore as a nonprofit corporation. My fellow Board of Directors members, **Dennis Bosch**, **Rick Spillane**, **Phil Solomita**, **Mike Goergen** receive my highest admiration and gratitude for the time, effort, and expertise that they expended in getting the new organization up and running.

The Management Council, which consists of committee chairpersons and administrative positions has been incredibly supportive of adapting new processes and procedures in bringing Omnilore LIR to life. Please look at their names in any Newsletter sidebar and thank them when you see them.

When we became a nonprofit, we hired Johan Smith as a part-time employee. As most of you know, Johan is an indefatigable force of nature who is a linchpin of the Omnilore organization.

We started out our tenure by signing a very favorable lease on our classroom space and

raising over \$50,000 to guarantee our start-up costs. We purchased new classroom computers, Zoom equipment and two 81-inch televisions to enhance the classroom experience and allow the choice of in-classroom or Zoom classes. The results of our membership survey this past spring showed that 87% were agreeable to Zoom-only or Hybrid Zoom classes. This is even though the vast majority agreed that in-classroom activities were the most rewarding. Just 13% would only support in-classroom-only S/DGs. The Board of Directors has decided to designate a percentage of our S/DG's as "in classroom only" to accommodate them.

To provide the in-classroom experience and more fully utilize our classroom space in the evenings and weekends, I proposed our new Lifestyles Activities Program. This is a program of S/DG's and other activities that may be less academic but still provide a stimulating and socially engaging experience. The *Films with Friends*, *Writer's Workshops* and *Field Trips* have been very popular. More are on the way.

A longtime goal of mine was to bring the ease and labor reduction of having the payment of fees, Forum tickets and donations available online. Through the efforts of **Al Ortiz, Elyse Gura** and **Larry Yuzuki** this was made possible. Over 75% of you paid online! This saves an incredible amount of time in handling and processing checks and the bookkeeping involved. Thank-you everyone.

I look forward to seeing many of you at our Annual Meeting and Forum on October 31st. For details see the Forum Flyer sent earlier. Don't forget that you can buy tickets online. See the link on our website: Omnilore.org or go directly to our website store.

These years of my tenure have been both challenging and rewarding. We will welcome a new Board of Directors at the annual meeting who will face a new set of challenges. The Nominating Committee has recruited an outstanding slate of officers for our Board of Directors. They are: President – Dennis Bosch, VP of Administration – Carolyn Pohlner, VP Academics – Karol McQueary, Treasurer – Wendy Morgan, Corporate Secretary – Adrian Pruetz. Omnilore Profile: Adrian & Rick Pruetz

The Pruetzs enjoy an active life of bicycling, gardening, cooking, traveling, conducting research for an upcoming book, or caring for their five grandchildren.

Both Adrian and Rick grew up in the Midwest before arriving in the Southland in 1984. Adrian's job offer to be an intellectual property lawyer for Morrison & Foerster is what enticed the couple to move their family out West.

Adrian describes herself as a city girl from Chicago, Illinois and Rick considers himself a country boy from Milwaukee, Wisconsin. She laughed that she visited the countryside when she was a girl and saw cows and horses from the vantage point of the car's interior.

Adrian fondly recalls growing up with a large extended family and walking to school with her cousins. Her mother was one of nine children, and her father was one of five. As a teenager, she worked in her parent's grocery store as a checker.

Rick recalls his childhood as a Happy Days environment, with pleasant winter days ice skating, swimming in the summer, and playing the trombone in his high school marching band. He spent a lot of time outdoors and credits a canoe trip as a child to the Boundary Waters as a formative experience which laid the foundation for him as a "nature lover and tree hugger."

At 13, Rick was a caddy at a country club. This job qualified him for a full scholarship to the University of Wisconsin, Madison as an Evans Scholar. At the university library a mutual friend introduced Adrian and Rick. Their first date was to a PDQ Bach performance.

Rick earned a bachelor's degree in communications and was only a semester into a graduate degree in mass communications when drafted into the Army during the Vietnam War. Rick says that his service was easy, and he hypothesizes, with a glint in his eye, that because he was a college graduate the military kept him away from the younger recruits.

The couple married then Rick was stationed in Texas, Atlanta and Korea. While in Korea, staff reduction enabled him to be discharged from service early where he could finish his interrupted master's degree at Northwestern.

After obtaining his masters, Rick wrote and produced TV commercials for Montgomery Ward and then for an advertising agency. Ultimately, Rick left his advertising career, pursued an advanced degree in urban planning at the University of Wisconsin, Milwaukee and became a city planner. He was a city planner for many years in Waukesha, Wisconsin.

After the family's move to California, Rick worked as the city planner of Burbank. "It was a great position because it is a big enough city to have an airport and industry, but small enough that the city planner could do some hands-on planning."

Eventually he left Burbank to start his own company as an urban planning consultant, which is still going strong 20 years later. The company helps cities and counties preserve landmarks, farmlands, and places of historical significance. Rick is semi-retired and still juggles numerous jobs along with



his active schedule.

In addition to planning, Rick is an author. He has already written eight books, ranging in topics as varied as the economic benefits of bicycle trails to a golf joke book. His books are available on Amazon, and one also on Audible.

Rick is also the Vice President of the Board of Ecocity Builders, a nonprofit which provides guidelines for city planning departments to have a balanced relationship with nature. The group just completed a project for Morocco.

Adrian was two years behind Rick in school. She had completed three years at the University of Wisconsin when Rick was drafted, and after her stint as a

military spouse, she finished her degree in English at Loyola University in Chicago. Adrian wanted to work in business. She landed a job at a big Chicago bank doing auditing. While working at the bank she pursued an MBA. However, she did not feel that she had really found her niche.

During this time Adrian's brother was thinking of becoming a lawyer. Adrian helped him study and her own professional career as an attorney was launched. She obtained her JD in 1982 from Marquette University Law School and became a trial lawyer.

In the beginning she did not specialize and worked on intellectual property (IP), product liability, civil racketeering, and business cases. Eventually she specialized in IP. Adrian worked for several firms including Quinn Emanuel where she was the head of the IP practice. While at Quinn Emanuel her daughter began to clerk for the firm, then was hired as an attorney and she too specialized in IP law.

Eventually mother and daughter left to create their own practice in 2007 and then moved together to Glaser Weil in Century City. Adrian feels lucky she and her daughter were able to work together for fifteen years.

Among Adrian's most interesting clients were biotechnology firms Roche and Genentech, electronics firm Vizio, Nike and Mattel. Adrian reports, "I have a great Barbie collection." She also mentioned that "Ken is considered an accessory and many parents have found poor Ken face down in a sand pile."

The couple has two children. A son, Jay, who is a pediatric cardiologist and has three children; and a daughter, Erica, an IP lawyer with two children. All children and grandchildren live in Los Angeles.

The couple has been in Omnilore for five years. Adrian was the catalyst for joining, prodded by her daughter to cultivate friends and enjoy life after a busy working career. Listening to her daughter's advice, Adrian joined a women's group and several of those women were Omnilore members including Bonny Kamen, who convinced her to try Omnilore. Since Adrian was considering taking classes, Omnilore appealed to her.

Adrian knew that when she retired from her busy career, which took a lot of mental energy, that she would want something with an academic bent and *Continued on Page 4.*

the ability to explore topics that her busy career kept her from delving into. Now she says that "Omnilore is a cornerstone of retirement for me."



Report on the July 31st Forum Speaker:

Forum Speakers Ms. Jennifer Addington and Dr. Sara Deen Spoke on The Power of Words, Book Banning and Its Implications

ennifer Addington, Director of the Palos Verdes Library District and Dr. Sara Deen, PVUSD governing board member, provided us with engaging food for thought in their presentation, The Power of Words, Book Banning and Its Implications.

Both are personally well acquainted with the recent uptick in local and national book banning campaigns that target public schools and public libraries, fueled by our current nationally polarized environment.

These institutions now face concerted challenges by well-organized groups whose agendas seek to politicize what

happens, and what doesn't happen, in our libraries and classrooms. Active censorship is happening right here in Southern California, and is cause for concern.

Our speakers identified the most frequent topics being target-

ed by these current book challenges: gender identity and how our country's history with racism is addressed in textbooks and on library bookshelves.

Banning books that some groups find objectionable, from educational curricula and school and library bookshelves, can easily hamper creativity and intellectual freedom, suppress open sharing of knowledge and ideas and stifle informed public discourse. We've seen instances of censorship throughout history, and it's never pretty.

Both Ms. Addington and Dr. Deen are advocates of equitable and excellent education for every student, and libraries where collections of materials with diverse points of view can be found - re-

gardless of where readers begin life, who they are, or how they learn best. Adequate and comprehensive resources are necessary to allow for this to happen.




Have You Read....?
